The substitutive declarations of the deed of notoriety, governed by art. 47 of Presidential Decree 28 December 2000, n. 445, replace not an administrative certification, but a notoriety deed that belongs to the category of verbalizations.

With the substitutive declaration of the deed of notoriety, the following can therefore be certified:

- the facts, personal qualities and states of knowledge of the person concerned, not included in the list of self-certifying data with self-certification.
- compliance with the original of the copy of a document issued by a public administration, of a publication or of a qualification (Article 19 of Presidential Decree 445/2000).

The qualifications / publications for which conformity with the original is certified can be included in a single substitutive declaration, but must be expressly indicated, as a generic expression such as "... all documents / publications attached to the application comply with original...".
